- Works submitted must be original and not published or submitted for other journal. Manuscripts will be reviewed by the editor and consultants, and are subject to editorial review. Authors should follow the guidelines described below.

## GUIDELINES FOR SUBMISSION OF MANUSCRIPTS

- Manuscripts must be submitted in English.
- Despite of being published in English, Dental Press Implantology also has a Portuguese version. Therefore, submission of articles in Portuguese are also accepted.
- In this case, the authors should also send the version in English of the article with proper vernacular quality and identical content of the version in Portuguese, so that the paper may be considered approved.

## FORMAT OF THE MANUSCRIPTS

- Submit manuscripts through the website: [www.dentalpressjournals.com.br](http://www.dentalpressjournals.com.br)
- Organize your presentation as follows.

### 1. Authors

- The number of authors is unlimited; however, articles with more than 4 authors shall inform the participation of each author in the execution of the research.

### 2. Title page

- It must contain title, abstract and keywords.
- Information on the identification of authors (e.g.: authors' full names, academic degrees, institutional affiliations and / or administrative positions) must not be included. They should be included only in specific fields in the articles submission website. Thus, this information will not be available to reviewers.

### 3. Abstract

- Structured abstracts with 250 words or less are preferred.
- Structured abstracts must contain the following sections: INTRODUCTION, with the proposition of the study; METHODS, describing how it was conducted; RESULTS, describing the primary results; and CONCLUSIONS, reporting the conclusions of the study and the clinical implications of the results.
- Abstracts must be accompanied with 3 to 5 keywords, in accordance to MeSH ([www.nlm.nih.gov/mesh](http://www.nlm.nih.gov/mesh)) guidelines.

#### 4. Text

- Text must be organized into the following sections: Introduction, Material and Methods, Results, Discussion, Conclusions, References and Figure legends.
- Text must have a maximum of 3,500 words, including figure and table legends (excluding the data of tables), abstract and references.
- Figures must be sent in separate files.
- Insert figure captions also in the text, to guide the final layout of the article.

#### 5. Figures

- Digital images must be in JPG or TIF format, in CMYK or grayscale, with at least 7 cm width and 300 DPI of resolution.
- Images must be sent in separate files.
- If a figure has been published previously, its caption must give full credit to the original source.
- All figures must be cited in the text.

#### 6. Graphs or tracings

- They must be cited in the text as figures.
- Files containing the original versions of graphics and tracings must be sent, in the programs that were used for their confection.
- Sending them only in bitmap image (non-editable) format is not recommended.
- Submitted drawings can be improved or redesigned by the production of the journal, at the discretion of the Editorial Board.

#### 7. Tables

- Tables must be self-explanatory and complement the information presented on the text.
- They should be numbered with Arabic numerals in the order they are mentioned in the text.
- Supply a brief title for each table.
- If a table has been previously published, include a footnote giving credit to the original source.
- Submit tables as a text file (e.g., Word or Excel), and not as graphic element (non-editable image).

#### 8. Ethics Committees

- Articles must make refer to the opinion of the Ethics Committee of the institution, if applicable.

#### 9. Required statements

- All manuscripts must be accompanied with the following statements to be filled at the time of submission of the article:
- Cession of Copyright  
Transferring the copyright of the manuscript to Dental Press, if the work is published.
  - Conflict of Interest  
If there is any interest of authors to the object of research, this must be clarified.
  - Protection of Human and Animal Rights  
If applicable, inform the compliance to the recommendations of international protection entities and the Declaration of Helsinki, respecting the ethical standards of the responsible committee on human/animal experimentation.
  - Permission for using copyrighted images  
Original or modified illustrations or tables of copyrighted material must be accompanied by the owners' and original author's permission to use these rights (and the figure caption must provide correctly credit to the source).
  - Informed Consent  
Patients have the right to privacy that should not be violated without an informed consent. Photographs of identifiable persons must be accompanied by an authorization signed by the person or parents/guardians, in the case of under age. These authorizations must be indefinitely saved by the author responsible for the article. A cover sheet should be sent stating the fact that all patients' authorizations were obtained and are in possession of the corresponding author.

#### 10. References

- All articles cited in the text must be included in the reference list.
- All references must be cited in the text.
- To facilitate the reading, the references are cited in the text only indicating their numbering.
- References should be identified in the text by superscript Arabic numerals and numbered in the order they are cited.
- Abbreviations of journal titles must be standardized according to the "Index Medicus" and "Index to Dental Literature" publications.
- Accuracy of references is the responsibility of the authors and they must include all information needed for their identification.

- References must be listed at the end of the text meeting the Vancouver Standards ([http://www.nlm.nih.gov/bsd/uniform\\_requirements.html](http://www.nlm.nih.gov/bsd/uniform_requirements.html)).
